**Our mission is to use research, advocacy, and organizing to show how over-criminalization and mass incarceration harm individuals and undermine our communities and the national well-being. This year's publications explains how probation fees hit poor communities hardest; identify key stakeholders who benefit from maintaining the \$182 billion-per-year system of mass incarceration; shift the debate on jail policy from the local to the state level; and shine a light on the 12 states and D.C. that still enforce the outdated federal law that suspends driver's licenses for people convicted of unrelated drug offenses. Our work on communications shed new light on the high cost of in-state phone calls from jails, and how private companies have worked to evade regulations put in place by the FCC last year. Continued.
