REVENUE SHARING AND SERVICE AGREEMENT

BETWEEN HOMEWAV, LLC

AND

ADAMS COUNTY, MISSISSIPPI

This Agreement ("Agreement"), made and entered into as of this 13 day of June, 2013 between Adams County, MS, through its authorized representative (the "County") and HomeWAV, LLC, a Virginia limited liability company ("HomeWAV").

RECITALS

Whereas, the County requested, and HomeWAV has submitted, a proposal for the installation of a fee-based, revenue sharing, inmate video visitation system that consists of certain equipment ("Equipment") that will operate using HomeWAV's proprietary and patent pending software program (the "System");

Whereas, the System will be installed and operated in the County's detention facility (the "Facility") and will provide inmate video visitation over the Internet; and

Whereas, HomeWAV will deliver and install the Equipment and provide the System, and the County will accept HomeWAV's Equipment and will make use of the System, pursuant to the terms set forth.

Now, therefore in consideration of the mutual covenants and promises contained herein, the parties, desiring to be contractually bound, agree as follows:

1. **Term of Agreement.** This Agreement shall continue for a five (5) year term ("Term"), commencing on the date when installation of the Equipment, and the System, in the Facility is complete. This Agreement may be extended on such terms and conditions as the parties may mutually agree. At no expense to HomeWAV or the County, HomeWAV may remove the Equipment from the Facility at the expiration of term of this Agreement, as extended.

2. **No Charge for Equipment or System.** HomeWAV will; (i) arrange for the delivery of the Equipment to the Facility, (ii) load its software into the Equipment, (iii) coordinate the installation of the Equipment in designated wall mount locations within the Facility, (iv) install electrical service and CAT-5/Coaxial data cable inside the Facility at such locations as required to operate the Equipment and the System, (v) provide Jail Management System Data to HomeWAV prior to shipment of Equipment, and (vi) arrange initial training of jail personnel, all at no charge to the County.

3. **No Charge for Maintenance.** HomeWAV will service and maintain the Equipment in the Facility at no charge to the County for the term of the Agreement.

4. **Title and Shipment of the Equipment.** The County shall take title to the Equipment FAS HomeWAV's place of business in Virginia. HomeWAV, at its sole expense, shall arrange, and pay for, the shipment and delivery of the Equipment to the Facility, through qualified third party subcontractors.

5. **License for Use of System.** HomeWAV hereby grants to the County a non-assignable license to use its System, at no charge, for the limited purpose of allowing the Equipment to provide Internet video visitation to inmates in the Facility pursuant to the terms of this Agreement.

6. **County's Representations and Responsibility.** The County represents that approximately 94 inmates are currently housed in the Facility. The County will allow HomeWAV's contractors between the hours of 8 a.m. and 5 p.m. to install the Equipment and to test the System in the Facility. Subject to lock-downs, suspension of inmate privileges, and other temporary interruptions, the County will allow inmate visitation on the System during the same hours when inmates are allowed to use the Facility's inmate phone system at a minimum. The County will arrange, at its expense, for high speed Internet service to be extended to the Facility.

7. **System Usage Fee.** The Facility's inmates' visitors shall be charged fifty cents (\$0.50) per minute usage fee ("Usage Fee") to take part in video visitations using the System. The Usage Fee shall be deposited by the inmate's visitor directly into a dedicated account established and maintained by HomeWAV through PayPal, or another equivalent third party ecommerce vendor.

8. **Revenue Sharing/Free Visitation.** HomeWAV will receive 100% of the revenue from Usage Fees from inmate video visitation using the Equipment and the System in consideration for the payment for the Equipment, Installation costs and the ongoing licensed right to use the System.

9. **Agreement documents.** HomeWAV will provide and install 10 visitation stations in the locations described in Exhibit A. The attached Exhibit A, as well as any other addendum that may modify the terms hereof, are made part of this Agreement and are incorporated herein by this reference.

10. **Indemnification.** HomeWAV will indemnify the County, its officers, agents and employees from all suits, claims, actions or damages of any nature brought due to the breach of this Agreement by HomeWAV, its subcontractors, agents or employees or due to any negligent act of HomeWAV, its subcontractors, agents or employees.

11. **Governing Law, Jurisdiction, and Venue.** This Agreement shall be governed by the laws of the Commonwealth of Virginia, both as to interpretation and performance. The state Circuit Courts of the City of Virginia Beach, Virginia and the federal courts for the Eastern District of Virginia, Norfolk Division, shall have exclusive jurisdiction and venue over any disputes which arise between the parties hereunder.

12. **Independent Contractor.** HomeWAV acknowledges that HomeWAV and its employees serve as independent contractors and that the County shall not be in any manner responsible for any payment, insurance, or incurred liability. Nothing in this Agreement will create an employer-employee relationship, association, joint venture, partnership, or other form of legal entity or business enterprise between the parties, their agents, employees or affiliates.

13. **Limitations of liability.** In no event shall County or Home WAV be liable for any indirect, incidental, consequential, special or exemplary damages or lost profits.

14. **Nondiscrimination and non-conflict statements.** Home WAV agrees that no person on the grounds of handicap, age, race, color, religion, sex or national origin, shall be excluded from participation in, or be denied benefits of, or be otherwise subjected to discrimination in the performance of this Agreement, or in the employment practices of HomeWAV. HomeWAV shall upon request show proof of such non-discrimination, and shall post in conspicuous places available to all employees and applicants notices of nondiscrimination.

15. **Compliance with all federal, state, and municipal laws.** HomeWAV is familiar with, and agrees to observe and comply with, all federal, state, and local laws, statutes, ordinances, and regulations in any manner affecting the provision of inmate video communication, and shall ensure that its third party subcontract installers obtain any necessary permits prior to installation of the Equipment in the Facility.

16. **Severability clause.** If any provision of this Agreement is declared illegal, void, or unenforceable the remaining provisions shall not be affected but shall remain in force and in effect.

17. **Installation Date.** The County will use its best efforts to allow installation of the Equipment and the System in the Facility to commence within 30 days after full execution of this Agreement.

ADDENDUM ONE

This is addendum one to the Revenue Sharing Service Agreement (the "Contract") between HomeWAV, LLC ("HomeWAV") and Adams County, Mississippi (the "County") dated June 13, 2013.

Delete the first paragraph of the recitals in entirety and replace with:

Whereas, HomeWAV has submitted a proposal to the County for the installation of a fee-based, revenue sharing, inmate video visitation system that consists of certain equipment ("Equipment") that will operate using HomeWAV's proprietary and patent pending software program (the "System");

Add to the end of paragraph 3.

HomeWav shall replace any equipment as necessary at no charge to the County.

Delete paragraph 11. in its entirety and replace with:

11. **Governing Law, Jurisdiction, and Venue.** This Agreement shall be governed by the laws of the State of Mississippi, both as to interpretation and performance. Venue is proper in any state court in Adams County, Mississippi.

All other terms and provisions of the contract dated June 13, 2013 remain in effect.

Jail



Located at 306 State Street, the Adams County jail hosts an average population of 90 people per day. With jail security being a top priority for the Sheriff's Office, all correctional officers are required to complete 120 hours of training through the Southwest Mississippi Training Defense Academy, located on Foster Mound Road. There, these officers are trained in self defense, CPR, first-aid, OC Spray and most officers are taser certified. Aside from the training officers receive at academy, they also must complete a state certified curriculum.

The Adams County Jail includes wings for both male and female inmates. Juveniles are housed in a separate facility. Church services are available for all inmates through our ministerial program. Any drug, alcohol or anger management meetings or counsellings are generally court ordered. Daily operations of the jail involve our inmates taking on the jobs of assisting food service personnel, cleaning, washing and detailing deputies' vehicles as well as working litter detail.

The jail employs a health care provider who visits the jail 3 times a week and is on call 24/7. Before any inmate receives or takes any medication, the health care provider must approve it before being administered. If an inmate is on medication, a family member must bring the medication that the inmate is currently on in its original bottle. Any medication that is out of date will not be passed along to inmates, but rather thrown away.

The Adams County Adult Detention Center now has a full-time transport deputy which transports inmates to and from any medical, court or other appointments they might have.

MAIL

- All incoming mail is delivered to inmates Monday - Friday after being inspected for contraband.
- All mail received must have the sender's first and last name on the return address (a complete address.)
- NO PACKAGES will be accepted through the mail.
- Clearly **PRINT** address as follows:

COMMISSARY

- Inmates are only allowed to accept money orders - Cash and personalized checks **WILL NOT** be accepted.
- Money orders **MUST BE RECEIVED by Sunday at 5 p.m.** to be able to send off for the inmate's commissary order.
- Each money order must be written to the name of the **receiving inmate/ACSO**.
- There is a **\$25 maximum limit** on each commissary order placed by an inmate.
- Inmates are allowed **ONE** commissary money order per week.

VISITATION

Inmate Video Visitation Only. There is no visitation at the jail.

Be advised that ***Inmate Video Visitation*** is now activated.

In addition to inmate video calls, family relatives & friends can leave video messages on the video terminals for inmates. Notices of messages will appear on the video terminals advising inmates to retrieve the message. Note, that family, relatives & friends can only send video messages. They are not able to make a video call direct to an inmate. All video

calls must be initiated by the inmate.

Family, relatives & friends of inmates incarcerated in the Adams County Jail must visit the HOMEWAV web site www.HomeWAV.com to set up accounts which will enable face-to-face video visits. Any questions regarding accounts for inmates must be directed to HOMEWAV at 877-241-7559.

Precautions!

Family & friends should be advised of the following precautions in order to avoid poor quality audio or video during Inmate Video Visitation:

- Use only high-speed internet connections for best quality video & audio
- Close all other windows and applications – Other window activities take up bandwidth, and will slow down reception
- Install anti-virus software, and clean cookies, spam, viruses, etc. from computer on a regular basis – All of this can slow down a computer
- Find the strongest signal – PC's and Laptop's will get the strongest signal if the Ethernet cable is plugged directly in to device. When using Wi-Fi, move as close as possible to the router.
- Use headphones or ear buds when using SmartPhones to avoid audio interference (Echo).

Call quality for cell phones will vary depending on how strong the cellular signal is. Check the cell phone signal strength (how many bars are indicated on the cell phone signal indicator?)

DELIVERIES

- All Personal items are provided for inmates by the Adams County Sheriff's Office Jail.
- **No packages** will be accepted from outside the facility.

PHONE CALLS

- All phone calls made by inmates are collect or family members may purchase minutes for an inmates' account by calling Securus Technologies at 1-800-844-6591.

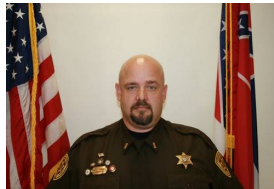
FINGER PRINTING
